- 2. Bernie conducted the swearing in process for Diane Malette as a new steward for the School of Access, Skills Training and Building Sciences

 - Bernie explained that a new violence policy is in its first phase of introduction to the college as a result of Bill 168 which puts the onus on management to be aware of potential violence problems
 - It's not yet clear what staff training might be available for college adaptation to the new legislation

- Local 421 Gord informed the LEC that his local has filed for arbitration on one classification grievance

- Quinte Labour Council nominations for a new slate of members is approaching and Wayne indicated that he has put Gord Wright's name forward
 - Wayne has recently been working on 4 Employment Insurance cases, one of which has been a farm labour case that is tantamount to a slavery issue – 16hrs/day/no visitors/no min wage

Board of Governors

- On the question of a salary freeze for administrative salaries and how that will affect the salaries of Loyalist managers, Pat reported that Karen Cullen says the wording of the province's March 25th salary freeze alert was vague and that a more definitive interpretation is being sought before any commitments can be made
- new provincial Second Career funding has been announced which will be good for Loyalist
- a recently released Procurement Ethics Report will have significant impact on Loyalist's procurement procedures and on bidding procedures (tenders) for services and supplies
- Pat reported that there is a new student representative on the board of governors like his predecessor he is a 3rd year Accounting student
- Pat announced that the college budget looks promising in terms of program and staff stability
- Motion to receive the report (Tay/Ryckman) carried

- President
 - Bernie announced that the College Council is coming to Loyalist to review the implementation of the new collective agreement sometime in the near future (no date announced yet)

• Vice President –

- Pat explained that the release time allowed to her as Vice President of the Local is supposed to come from her teaching contact hours on her SWF, not from the complementary functions hours
- This will affect Bruce Wright too (same dept/dean)
- A discussion of the timing of "program reviews" indicated that these need to be SWF'd during the academic year ... if such a review is not on your SWF's sometime during the teaching year, it can't be scheduled <u>for you</u> in the spring after classes are finished
- Motion to receive the report (Bolton/Tay) carried

Chief Steward

- Eugene reviewed the grievances that are still "on the books." Concern was expressed about placement coordinators who might be trying to willingly give up work that they have traditionally done
- Eugene noted that smoking problems still exist at entrances –
 complaints have been made but it looks like a grievance is going to be
 required before any corrective action takes place
- The arbitration stage has been reached with the violence grievance that has been pending for many months
- Eugene provided a brief report on the recent provincial presidents & chief stewards meeting, noting that the arbitrator is scheduled to meet on May 7 to decide compensation on arbitration awards that haven't been finalized
- There was discussion of the processes to follow in future rounds of negotiations and the optimum timing for providing mandates to our negotiating team
- Eugene reported that the locals in our bargaining unit are generally blaming the acceptance vote in our most recent round of negotiations on the increases in the number of partial load faculty
