- <u>Quinte Labour Council</u> Wayne Boicey asked Local 420 to let him know right away if the college faculty rejects management's offer and go out on strike, so that he can rally the QLC's support and display of solidarity
  - Wayne updated the LEC on his dealings with the EI Board of Referees citing a local unemployment rate of around 10% and noting that, on average, only 3 of 10 people who are laid off process EI claims and there are others for whom EI payments have run out.
  - He also told us that the EI rules for qualification do not seem to be consistent. Some "offshore workers" are in receipt of EI but haven't been in Canada long enough to qualify. One fisheries worker who came to the area from the Maritimes had apparently put in enough hours to qualify for EI but was told that she hadn't earned enough money to claim it.
