- Health and Safety Committee Vicki Ryckman provided a brief update on recent meetings and activities and reminded members of the planned June 5th 6th H&S presentation on Violence Prevention. Faculty interested in attending this workshop should confirm their intentions with Janet Mathany. Level 1 Health & Safety certification will be awarded to faculty attending this presentation/workshop
 - February 8th was the most recent meeting of the committee and much of it focused attention on committee inspections and whether inspection recommendations have been followed up by managers – manager response has been better lately
 - Dave Stewart mentioned that there has been some issue with cables and wiring in the classrooms. He noted that the recent installation of ceiling hookups for these has helped to alleviate the associated slip/trip hazards. Some students may be hired to help with the ceiling installations over the upcoming summer months.
 - Dave also advised the members that management is talking of a policy to address the problems connected with personal electrical appliances in office areas the age of the wiring in much of the

college is not designed for the load demands that some of these appliances are placing on it. – Motion to receive the H&S Committee report (Tay/Dockrill) – Carried

- Local 421 Gord Wright reported that his Local has a General Membership meeting and elections scheduled for March 5th, 2012

- Board of Governors Pat confirmed that MTCU is expecting Colleges Ontario to "do more with less." Articulation agreements are being encouraged. Funding from the province for colleges does not cover 100% of operating costs; individual colleges have to generate a portion of these. At Loyalist one of the main sources of revenue for the college has been the international certification services which has unfortunately slumped somewhat in recent months. The second life program has also been an important source of revenue
 - Pat reported that the BOG is generally optimistic about the faculty negotiations for a new collective agreement being concluded before September
 - The new budget is due to be presented at the next board meeting
 - Maureen Piercy hopes to maintain the staffing complement through next year. Motion to receive the BOG report (Ryckman/Rendell) – carried
