- Quinte Labour Council Gord reminded the LEC that the QLC will be holding its annual general meeting Alhambra Hall on May 1^{st.} The meeting will start at 5:30 p.m. and dinner will be at 6:00. Bernie plans to attend.
 - At the most recent QLC meeting there was discussion of the Drummond Report, a review of QLC bylaws that resulted in some revisions which will be forward to the CLC for approval
 - QLC workers are currently staffing a help centre in the United Way building for EI applicants, to assist with form completions
 - Bernie said that he will send in a cheque for our membership on the QLC
 - Motion to receive the QLC report (Tay/Bolton) carried
 - Board of Governors Pat reported that there has been considerable discussion about the PQA process and that MTCU plans to both help smooth the process
 - The province is also planning to conduct a provincial audit of the PLA process. Mark Gallupe and Paul Zakos have been working on an updated report on PLA at Loyalist. Without

- formal recognition of PLA at the college provincial funding may suffer.
- Colleges will generally be expected to explore and develop more "pathways"/articulation agreements, particularly with universities
- The Board of Governors is seeking ideas on different ways that Loyalist can brand the college's uniqueness
- HR reported to the BOG that they are developing a "whistle-blower" policy designed to protect people who speak up about problems they have witnessed within the college. Motion to receive the BOG report (Rendell/Tay) carried

8. Officers' reports

- President Bernie reported that the VP Academic had called asking him to explain why he refused to complete the student retention report unless it was on his SWF. Bernie contends that because this is additional, new work it cannot be covered by the 6 hours of complementary functions that are allowed for on his SWF. Pat noted that any faculty confronted with the same problem should be advised to be aware of the problems involved in completing the report and to ask for clarification on the requirements of the request
 - Bernie expressed concern that negotiations are going to be tight again this year.
 - Motion to receive the presidents report (Keller/Tay) carried
- Vice President Pat had no formal report from the board but asked stewards to make sure faculty understand that if the meetings are included on their SWF's, they are obligated to attend meetings that are called in May and June - otherwise they are not. She reminded us that workload averaging is no longer legitimate.
 - Motion to receive the Vice President's report (Bolton/Rendell)
 carried
- Chief Steward Eugene reviewed the grievances that are currently on the books and noted that the arbitrators have finally agreed to hear specific cases requesting remuneration as a result of the strike of 2006. From there they will decide whether to hear all cases or use the `pilot` cases as typical, and rule from there.
 - Motion to receive the Chief Steward's report (Dockrill/Wright) carried
- Treasurer Bruce reviewed the Local 420 Income Statement to the end of February, 2012 and the General Ledger Report for 01/02/2012 to 29/02/2012. He noted that the local is on track with the budget but that parking and release time costs still need to be resolved
