- 1. Call to order -5:30
- **2. Motion to amend the agenda** to include the election of a new secretary to replace Brian Gibb (Belanger/Tay) carried
- 3. Adoption of agenda as amended (Belanger/Tay) carried
- **4.** Next meeting date June 12<sup>th</sup>, 2012; 5:30 p.m. at Paolo's Trattoria
- **5. Minutes of previous meeting** motion to adopt the minutes of the April 24<sup>th</sup>, 2012 meeting of the LEC (Boltonl/Malette) carried
- **6. Business arising from the previous meeting** Pat reported that the Board of Governors has not finalized the budget yet but that the board has approved the college's business plan this led to some discussion of the closing of the ECE daycare centre. Bernie noted that the current academic collective agreement has finally been printed but it has not yet been distributed to all of the members.
- **7. Resignations, Nominations and Elections** Bernie called for nominations for the position of Secretary to the LEC. Dave Stewart was nominated and elected

#### 8. Committee reports

- Health and Safety Committee Dave reported that there had not been a
  meeting of the committee in May. He added that many of the H&S
  Committee's recent concerns have focused on "cord" management
  (electrical extension cords, network cords, telephone cords, computer
  wiring, etc.) These amount to a "ton" of code violations and need to be
  addressed. He also noted that a personal electrical appliance policy is in
  the works which will lead to the need for facilities services approval for
  personal appliances being brought into staff offices.
  - Motion to receive the health & safety committee report (Dockrill/Heidendahl) carried
- College Employment Stability Committee nothing to report as the committee has not met yet. Bernie announced plans to explain the role of this committee at the upcoming General Membership Meeting

- Union College Committee no report
- Workload Monitoring Group nothing to report
- Local 421 Gord Wright reported that his local received notice of the daycare centre closure on May 11<sup>th</sup> and that no 2-week advance notice had been given to the local although four full-time support staff were directly affected by the closure. Local 421's Employment Stability Committee is having talks with the college. The expected process for announcing the closure with the potential for lay-offs was not followed and no written notice was given to any of the four staff directly affected
  - Gord also reported that one of Local 421's classification grievances has gone to arbitration
  - Motion to receive Local 421 report (Tay/Waite) carried
- Quinte Labour Council Gord reported on the QLC's May 1<sup>st</sup> Annual General Meeting during which a new slate of officers, including Donna House as President, was elected. The next meeting of the QLC is scheduled for June at which time the Doug Sword scholarship will be on the agenda. Gord is a member of the QLC.
  - Motion to receive the QLC report (Lafreniere/Malette) carried
- Board of Governors Pat reported that the B.O.G. has not yet approved the college budget but confirmed that there would not be any increase in parking fees. At the same time she added that there would not be any additional paving or parking lot improvements in the coming year.
  - Pat explained that since becoming president, Maureen has liked to work on a series of 5-year plans which, this year, Alan Ross will play a key role in helping to develop
  - The board is investigating several ways of attracting new funding; Second Career activity has played a major role in helping the funding scene at Loyalist over the past couple of years
  - Motion to receive the BOG report (Tay/Bolton) carried

#### 9. Officers' reports

- President Bernie told the LEC that our current collective agreement have arrived from publication & will start to be distributed this week
- Bernie drew attention to the administrative restructuring announcement scheduled for Friday
- He announced that bargaining will begin in June and that the 389 demands that came in from across the province have been

"boiled down" to 29 – none of which most feel would be worth striking for; however, he noted that there is cross-province resounding opposition to management any attack on SWF's. Bernie will be sending out an email to members asking them for updates on their personal contact information and noted that the Local will begin developing strategies for strike action

- Bernie reiterated the information that there will not be any increase in parking fees and that the college has backed off the planned 6% increase.
- Motion to receive the president's report (Bolton/Wright) carried
- Vice President no report
- Chief Steward Eugene updated members on progress being made with the current list of grievances; he added that the anti-smoking campaign will be re-launched in the fall.
  - Motion to receive the Chief Steward's report (Heidendahl /Lafreniere) carried
- Treasurer Bruce updated the committee on the financial status of the Local providing a report on the 2011-12 budget to the end of April. He noted that partial load dues were a little lower than anticipated and that we were under budget in the parking category because of the reduced number of partial load faculty. He also noted that there are still two further quarters of rebates to come from OPSEU head-office. All in all the budget is in good shape.
  - Motion to receive the Treasurer's report (Bolton/Malette)

  - Bernie thanked Brian for his support of the Local and for his contributions to the faculty and students over the years and presented him with gifts of thanks from Local 420 in acknowledgement of Brian's upcoming retirement
